SIGNIFICANT ACCOUNTING POLICIES & NOTES FORMING PART OF ACCOUNTS

The Government of India, Ministry of HRD, New Delhi vide its order F. No. 11-10/2008-TS.1 (Pt) dt. 9th May 2008 has set up IIT Indore in Madhya Pradesh with the commencement of Academic Session from 2009-10. The Institute commenced operations from 18.02.2009. The Institute is registered under the Society's Act vide Registration No. 03/27/03/11934/09 dt. 10-07-2009. The Institute is fully funded by the Government of India, Ministry of Human Resource Development. The Institute prepares its Annual Accounts as per the common format prescribed for Autonomous bodies provided by the Government of India, Ministry of HRD, New Delhi in consultation with Comptroller and Auditor General of India.

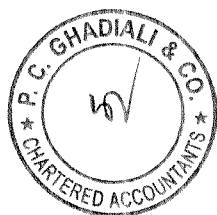
(1) **Accounting Convention :**

The Accounts are prepared on an Accrual Basis.

(2) **Fixed Assets and Depreciation :**

a. Fixed Assets are stated at cost of acquisition, inclusive of inward freight, duties and taxes and incidental and direct expenses related to acquisition.

Government of Madhya Pradesh has allocated 501.62 acres of land to Indian Institute of Technology Indore, out of which 318.11 acres of land has been transferred to Indian Institute of Technology Indore.



b. Depreciation:

Depreciation has been provided on Written Down Value Method as per Income Tax Act, 1961, as under:

Equipment	15%
Furniture & Fixtures	10%
Motor Vehicle	15%
Library Books & Journals	60%
Computer	60%

(3) Taxation:

Indian Institute of Technology Indore is exempt under section 10(23C)(iiiab) of Income-tax Act 1961, and hence no provision for Income-tax has been considered necessary.

(4) Revenue Recognition:

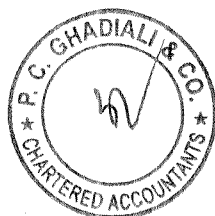
- a. Government Grants sanctioned but not received are accounted for on Accrual Basis.
- b. Fees from students are accounted for on cash basis.

(5) Investments:

All investments of the surplus money of the Institute are made as per the guidelines provided by the Govt. of India, Ministry of Human Resource Development on the subject. All investments are valued at cost.

(6) Retirement Benefits:

Retirement Benefits such as Gratuity, Leave Encashment etc. are at actuals.



(7) **Contingent Liabilities:**

- (a) There is no claim pending on account of disputed items in respect of Income-tax, Sales Tax, Municipal and other Taxes.
(b) Capital Commitment is ₹ 732 Lakhs and Advance paid towards the same is ₹ 0.1 Lakhs.

(8) **Current assets, loans and advances:**

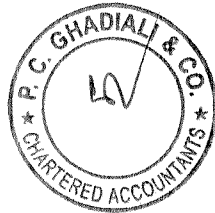
In the opinion of the Institute, the current assets, loans and advances have a value on realisation equal to the amount shown in the Balance Sheet.


(9) **Adjustment of Advances/Letter of Credits**

The expenditure against these Advances/Letter of Credits is accounted for only on the receipt of documents such as bills and acceptance/installation/commissioning, certificate from the indentor.
