- 3) The competent authority on behalf of the IIT Indore does not bind him to accept the lowest or any other offer/tender and reserves to itself the authority to reject any or all the offer/tenders received without assigning any reason. All offer/tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the offer/tender shall be summarily rejected. Conditional offer including conditional rebate shall be summarily rejected.
- 4) No work will be sublet to third party. If found, payment of final bill will not be processed and the contractor's name will be blacklisted from the institute without giving him further notice.
- 5) Procedure for submission of offer - offer must be submitted in sealed covers (through speed post / Courier/by person) super scribing the envelope with Tender for "Providing, fabricating & fixing Wooden storage wall unit, work station L type in Room no.502-A , PHY-1E, POD building IIT Indore, Simrol Campus"

- 10) Tenders shall be opened in presence of those tenderers who may choose to be present. All conditions stated in 'CPWD General Conditions of Contract-2014' and 'CPWD Manual 2014' shall apply.
- 11) Give authorization to your representative to deal any matter with any Officers or Staff of IIT Indore on behalf of you/your firm
- 12) .CLAUSE- 10,10B, 10C, 10CA, 10CC, 19L of CPWD GCC 2014 is not applicable for this work.
- 13) IIT Indore reserves the right to add/delete/amend the scope of work, if required
- 14) Rates of work order will be firm and no escalation will be paid
- 15) The rate shall include cost of all material, labour, transport, all taxes including GST; royalties etc complete, and nothing will be paid extra.
