2. The bidder has to get the ownership of the vehicles transferred in their name at their cost and risk and IITI will hand over the custody only after submission of documents ensuring the requisite compliances of Registration, Transport, Pollution, Insurance etc.
3. The Bidder/tenderers may inspect the vehicles/items/lots on any working days except Saturdays, Sundays and other closed public/Intervening holidays from as per the schedule at Page no. 01 of this document with prior appointment to satisfy themselves about the quality and condition of the . No request for samples or inspection/complaint what so ever will be entertained after submission of the Tender. No dispute with reference to description/condition etc. of the items/lots will be entertained. Mis-description by the institute on the details of the lot/unit due to inadvertence will not invalidate this tender.
4. Bidders/tenderers are requested to quote their competitive offers in terms of each lot and unit as the case may be, **BOTH IN WORDS & FIGURES** in the enclosed format. Overwriting/Corrections & Mutilation is not allowed. However, Corrections, if any, is/are to be attested with full signature. Offers received in any other form will not be considered. Tenders in Unsealed, crumpled, torn or illegible condition will be rejected.
5. Offers shall be valid for consideration only if they are accompanied with **requisite Proof of Online EARNEST MONEY DEPOSIT [EMD] submission in respect of the Lot/s or any of them**. 6. The vehicles are in **running condition** and are in use at the institute with complete registration and covered under insurance. However, the vehicles will be disposed off on

PM after which only the Gate pass will be issued by MMS on inspection by Security and after clearance by Transport department of the institute.

The successful bidders who would like to take delivery of the goods through their authorized representative/s should send an authorization letter with their personal identification such as Driving License card, Credit card, Income Tax, GST, PAN card, Aadhar Card etc. along with such person/s duly attesting his/her/their signature/s therewith.
17. The tenderers/bidders are requested to submit their competitive offers in the prescribed form (**Annexure-B &C**) with the requisite reference/proof of EMD submission in a sealed cover duly super scribed as '**TENDER FOR THE DISPOSAL OF VEHICLES**'.

10. The bidders/tenderers are requested to quote their **TIN, GST and PAN** invariably in their tender form to avoid any complication at later stage.
11. Valid tenders will be processed for further action, after their opening as scheduled. Written intimation to the successful bidder/s will be forwarded requesting him/her/them to pay the remaining bid value online within **SEVEN Days**. The successful bidder can lift the item on production of the requisite documents in Transport Section and lift the allotted vehicle/s concerned within **TEN DAYS** from the date of issue of the award letter.

The successful bidders shall lift the materials concerned at their cost (i.e. loading/unloading, weighing, clearing, transportation, registration, transfer of ownership and/or any other expenses etc.) within the stipulated time after effecting the full payment under valid **Gate Pass** [Non-returnable].
13. In case the lots are not lifted within the specified time Ground Rent equivalent to **Rs. 500.00 (Five Hundred) per vehicle per Day** will be charged for the period of **Seven Days**. The materials not so removed will be treated as abandoned lots and EMD and other amount paid will be **FORFEITED** without any reference to the bidders.
