- 4) The competent authority on behalf of the IIT Indore does not bind him to accept the lowest or any other offer/tender and reserves to itself the authority to reject any or all the offer/tenders received without assigning any reason. All offer/tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the offer/tender shall be summarily rejected. Conditional offer including conditional rebate shall be summarily rejected.
- 5) Procedure for submission of offer - offer must be submitted in sealed covers (through speed post / Courier/by person) super scribing the envelope with " Drilling, Construction and Commissioning of 8 Nos of Piezometers" in IIT Indore Simrol Campus "

- 9) Incomplete tenders, where alternate specification have been stated and rates tendered against them, tenders which are not signed by tenderers at appropriate places in schedule of work, conditions of contract, tenders received late, shall be rejected without assigning any reason.
