- 3) Tender submitted by the contractor should be properly sealed with signature otherwise tender will be rejected without assigning any reasons.
- 4) The competent authority on behalf of the IIT Indore does not bind him to accept the lowest or any other offer/tender and reserves to itself the authority to reject any or all the offer/tenders received without assigning any reason. All offer/tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the offer/tender shall be summarily rejected. Conditional offer including conditional rebate shall be summarily rejected.
- 5) Procedure for submission of offer - offer must be submitted in sealed covers (through speed post / Courier/by person) super scribing the envelope with " Construction of IIT entrance gate on approach road RD 12"
- 6) Tenders shall be accompanied by Earnest money and tender fees/cost by online mode. The tenders without EMD & tender fees will not be accepted. - in the form of FDR/BG should be made through digital means only. No cash/DD/cheque will be accepted.
- 7) Performance Bank Guarantee (PBG) @ 5% is required to be submitted after issue of LOA.
  - 8) 2.5% Security Deposit (SD) will be recovered from all running / final bills and SD will be released after 12 months of successful completion of building construction work. No interest will be paid on security deposit recovered from bills.
  - 9) Incomplete tenders, where alternate specification have been stated and rates tendered against them, tenders which are not signed by renderers at appropriate places in schedule of work, conditions of contract, tenders received late, shall be rejected without assigning any reason.
  - 10) The institute reserves its right to accept lowest or any tender, enter into negotiation with any or with a group of tenderers
  - 11) Tenders shall be opened in presence of those tenderers who may choose to be present. All conditions stated in 'CPWD General Conditions of Contract-2014' and 'CPWD Manual 2014' shall apply.
