ITEM NO. 11.1

Consider report of Director of the Institute.

11.1.1 Appointment of faculty members:

The BoG **CONSIDERED** and **RESOLVED** to rename the Centre for "Surface Science and Engineering" to "Material Science and Engineering".

11.5.1 The minutes of the 15th Building and Works Committee Meeting have been confirmed subject to the following:



15.3.2 The BWC **RESOLVED** to accord administrative approval for an estimated cost of ₹ 347 crores for the work of phase 1A (a). The tender document for the work of phase 1A (a) for an estimated cost of ₹347 crores should include the clause for bonus for early completion of work.

ITEM NO.11.6:

Consider extension of relocation expenses to the visiting faculty members subsequently appointed at regular positions in the Institute.

11.6.1 The BoG NOTED that Relocation Allowance for regular employees of the Institute was approved in the 4th Board of Governors meeting held on July 8, 2011 as per the Ministry of Finance, Government of India letter F. No. 19030/3/2008 -E.IV dated September 23, 2008 and even no. dated June 8, 2010 with the following restrictions:

In respect of Selected Faculty Members from abroad: Single airfare for self and spouse and cost of transportation of household goods at actuals up to a maximum limit of ₹1lakh.

In respect of Selected Faculty and non teaching staff members joining from within the country: Reimbursement as per entitlement for self and family and transportation of household goods at actuals with maximum limit of ₹75,000/-.

The institute actively engages, through the efforts of the Director during his trips abroad, to identify outstanding candidates for faculty positions. On occasions, the Director identifies and makes on-the-spot offers for visiting faculty member positions. Such persons are invited to join the institute as visiting faculty members and, subject to success in formal selection committee meeting, are then appointed as regular faculty members. This enables identification and selection of outstanding candidates.



- 11.6.2 The BoG CONSIDERED the recommendations of the Finance Committee in its seventh meeting held on January 13, 2014 and RESOLVED the following:
 - a) To extend the reimbursement of relocation expenses to faculty members from abroad who are appointed as visiting faculty members and then selected as regular faculty members.
 - b) Reimbursement of relocation expenses will also be made available to the following visiting faculty members from abroad, who have subsequently been selected as regular faculty members:
 - i) Dr. Vimal Bhatia
 - ii) Dr. Somaditya Sen
 - c) The relocation claim will be admissible on submission of undertaking by the regular employees, stating that "he/she should serve the institute at least for three years from the date of joining; otherwise the admissible amount will have to be returned to the institute."

ITEM NO.11.7:

Consider revision of financial limits for the purchase of goods/services on direct purchase basis and through a Purchase Committee.

11.7.1 The BoG **NOTED** the following:

a) Purchase of goods/services on direct purchase/without inviting guotation(s):

As per approved policy for purchase of goods in accordance to item number 5.10 of the fifth meeting of the Board of Governors, purchase of goods up to a value of ₹15,000/- (Fifteen thousand only) on each occasion may be made without inviting quotations / bids on the basis of a certificate to be recorded by the competent authority in the following format: "I______ am personally satisfied that these goods purchased are of the requisite quality and specifications and have been purchased from a reliable supplier at a reasonable price."



b) Purchase of goods/services through a Purchase Committee:
As per approved policy for purchase of goods in accordance to item number 5.10 of the fifth meeting of the Board of Governors, purchase of goods costing above ₹15,000/- (Rupees Fifteen thousand) and up to ₹1,00,000/- (Rupees One lakhs) on each occasion may be made on the recommendations of a duly constituted local purchase committee consisting of three members of an appropriate level as decided by the Head of School. Before recommending placement of the purchase order the committee will jointly record a certificate as under:

"Certified that we ______, members of the purchase committee are jointly and individually satisfied that the goods recommended for purchase are of the requisite specification and quality, priced at the prevailing market rate and the supplier recommended is reliable and competent to supply the goods in question."

- 11.7.2 The BoG reviewed the policy of several other IITs, IISERs etc. for purchase of goods/services through a Purchase Committee without the need for inviting quotations/bids, and considered bringing the IITI policy in line with that being followed in these other IITs, IISERs.

 The BoG recognized the need for the proposal of revising the financial limits for the purchase of goods and services in view of the inflationary trend experience during last couple of years and similar increased limits being followed by other IITs and IISERs.
- 11.7.3 The BoG CONSIDERED the recommendations of the Finance Committee in its seventh meeting held on January 13, 2014 and RESOLVED to revise the financial limits for the purchase of goods/services on direct purchase basis and through a purchase committee, at par with that followed by IIT Bombay, the mentoring institute.

- 11.8.2 Director briefed the members on the process used to estimate the budget requirements. Within each Discipline, the Head discusses the Discipline Faculty Members' requirements which are consolidated and then presented by the Discipline Head /School Head to the Director with adequate justification. The constantly evolving course curriculum, new research areas requiring special seed support as well as continuing active research projects requiring bridge support and some infrastructure requirements constitute some of the important parameters for budget allocation.
- 11.8.3 The BoG CONSIDERED the recommendations of the Finance Committee in its seventh meeting held on January 13, 2014 and RESOLVED to approve the budget of ₹37,540.96 lakhs for the financial year 2014-15.

- 11.11.2 The Board RESOLVED to ratify the above mentioned items approved by the Chairman

ITEM NO.11.12 (A) Consider payment of ₹1.26 crores to the forest department.

11.12(A).1 The BoG NOTED that construction of boundary wall in the forest area is hampered due to objection by the Forest Department, due to non-settlement of dues, amounting to ₹1.26 crores, by the State Revenue Department. The matter was brought before the Additional Principal Chief Conservator of Forest and the Chief Conservator of Forest. Permission to construct boundary wall in the forest area of the campus has been deprived, pending payment of the due amount. It is to be noted that the State Government, on an earlier occasion, when payment was due to the Forest Department, took over a year to do so, causing considerable delay in commencement of the campus development. It is imperative that the campus is made secure at the earliest, as on occasions there have been physical assaults on the institute's security personnel from miscreants attempting to fell trees in the forest area.



11.12(A).2 The BoG CONSIDERED the recommendations of the Finance Committee in its seventh meeting held on January 13, 2014 and RESOLVED that in view of the urgency and the dire need to have a secure boundary, the institute in the interim, immediately makes the payment of ₹1.26 crores to the Forest Department and pursue the matter with the Revenue Department to remit the amount to IIT Indore.

The meeting ended with a vote of thanks to the Chair.
