#### Agenda items of 47th meeting of the Finance Committee

47.1:

Opening remarks by the Chairperson, Finance Committee.

Comments from MOE (TE): "No comments."

Chairperson welcomed all the members and the newly joined Member of FC, Prof. Amod C. Umarikar. He also interacted with newly appointed Deans, Associate Deans and Heads

to congratulate them for their new assignments. Chairperson permitted Registrar to initiate the meeting as per the agenda after verifying the required quorum.

To confirm the minutes of the forty sixth (46th) meeting of Finance Committee held on May 4, 2023.

The Minutes of **forty sixth (46th)** meeting of the FC held on May 4, 2023 were circulated to the members and no comments were received.

The FC confirmed the Minutes.

To consider the Action Taken Report (ATR) on 46th meeting of Finance Committee held on May 4, 2023.

Comments from MOE (TE): "Action taken by the Institute may be noted."

Action Taken Report on the minutes were circulated amongst the FC members in advance to update them about the same.

Registrar & Secretary, FC informed the Committee members that in the 46<sup>th</sup> meeting of the FC vide agenda item no. 46.5 in the recommendation of the BWC, one of the BWC agenda items no. 61.7 regarding construction of 10,000 sq. ft laboratory at IIT Indore amount of Rs. 6.16 Crore is skipped to record in the Minutes of the Meeting.

Therefore, FC requested to consider the above amendments to incorporate in the Minutes and record the revised AA&ES as "the 6 works (recommended by the BWC 61.7, 61.11, 61.15, 61.18 and BWC 59.3(b) & BWC 60.3(a) worth of Rs. 29.95 Crore to be taken up. Out of this, an amount of Rs 4.07 is available from sanctioned HEFA loan."

By accepting the clarification offered, the FC permitted to record the above amendments and noted the ATRs with satisfaction.

47.4 To consider Annual Financial Statements for the Financial Year 2022-23.

The FC noted the details of the income and expenditure for the F.Y. 2022-23 as presented with satisfaction. Shri Anil Kumar, Director (IFD) from the Ministry suggested to utilize the available resources including the gained interest components for creation of academic and Research Infrastructure for the Institute in the long-term interest for the Institute.

This will also lessen the burden on grants which can be better utilized for the designated purpose.

FC recommended the Annual Financial Statements to the Board for approval.

To consider proposed fellowships for Mobility grant meritorious Ph.D. students and faculty members to increase International collaboration.

*Comments from MOE (TE): "May be considered subject to availability of funds with the Institute."* 

Prof. Avinash Sonwane, Dean of International Relations presented the fellowship schemes details before the FC (placed as Appendix-II) for outbound and inbound faculties and students. These schemes will help to promote collaborations, global academic & research partnerships and will also provide exposure to faculties and students in foreign universities. These schemes will also help us increase the internationalization and perception building of the Institute at a global level as envisaged in NEP 2020.

## The following were proposed:

#### a. Proposal for outbound international visit:

- (i) It was proposed to facilitate 10 meritorious selected Ph.D students for short term research fellowship program to visit Universities / Institutes to carry out academic and research activities. The students can avail the schemes with travel grants as per approved Institute norms (from Rs. 80,000 to Rs. 1.2 lacs) + living expenses of Rs. 35,000/- up to a period of three months only. This living expenses will be met from IRG of the Institute.
- (ii) Mobility grants to 10 faculty members to explore new research collaborations by visiting international universities / institutes which includes a round trip of economical travel grants as per approved Institute norms (from Rs. 80,000 to Rs. 1.2 lacs) + living expenses of 250 \$ per day up to a period of five days only.
- (iii) Mobility grants to 3 faculty members as per MoU to visit international universities / institutes which includes a round trip of economic travel grants as per the approved Institute norms Rs. 1.5 lac only.

The above proposals [sl. no. (i) (ii), (iii)] will be selected based on merit by an Institute committee. On return the visiting student and faculty member shall submit academic and research report to Dean, R&D.

#### b. Proposal for inbound international students:

(i) Short-term research fellowship program for 10 international Ph.D. students to visit IIT Indore which includes a round trip of economical travel grants as per approved Institute norms. The limit of the scheme is Rs. 2.25 lac per student in a year. This programme is only on reciprocal basis.

(ii) In bound UG/PG students under semester exchange program as per MoU

The scheme covers 5 international UG/PG students to visit IIT Indore which includes a round trip of economical travel grants as per the approved Institute norms (from Rs. 80,000 to Rs. 1.2 lacs). The travel grant will be utilized only once.

These two proposals will be as per MoU with the concerned University/Institute.

FC based on the deliberation recommended the proposal to the Board for approval.
