At the outset, the Chairman welcomed all the members present.

The Chairman thereafter took up for consideration the formal items of the Agenda.

#### **ITEM NO.8.1**

#### To consider report of the Director of the Institute.

- 8.1.1 Chairman informed that state of the art under-graduate teaching laboratories and research laboratories have been established by the Institute. During interactions with faculty members, they have expressed that the research facilities available at the Institute and the scope for research had attracted them to join the Institute. Chairman also informed that the credit goes to Director of the Institute for creating the state of the art research facilities in the Institute, thereby attracting the best faculty members to join the Institute.
- 8.1.2 Director informed that the under-graduate teaching and research facilities in respect of discipline of Engineering have been established at PACL Campus and in respect of discipline of Basic Sciences at the IET Campus.
- **8.1.3** Director also informed that the qualification in respect of Assistant Professor (Contractual) is Ph.D., however in respect of Assistant Professor (Regular) the faculty member should have three years post Ph.D. experience.
- 8.1.4 Director further informed that currently projects amounting to approximately Rupees Nine Crores have been sanctioned or approved. The School of Basic Sciences has 23 projects and the School of Engineering has 9 projects.
- **8.1.5** The impact factor for publications is discipline oriented; the impact factor is dependent on the number of scientists involved in research activities in a particular discipline.
- **8.1.6** Director informed that based on feedback from faculty members, various universities have approached for collaboration.

# ITEM NO. 8.3 Status of Campus Development.

#### **8.3.1** The Board **NOTED** the following:

Director, IIT Indore met Mr. R. Parasuram, Chief Secretary, Government of Madhya Pradesh in the forenoon, and Mrs. Ajita Bajpai Pande, Additional Chief Secretary, Government of Madhya Pradesh, in the afternoon of December 04, 2012 in Bhopal.

The Chief Secretary was apprised of the following:

#### Transfer of Land:

- a) Government of Madhya Pradesh has allotted 501.42 acres of land, details are as under:-
- i. **432.12 Acres (Government Land)**: The lease deed for 432.12 acres has been handed over to this institute on **June 27, 2012**.
- ii. 40.28 acres (Exchange Land) and 29.02 acres (Nizi Land): Mutation of Land in the name of IIT Indore is pending with the Government of Madhya Pradesh.

In his meeting with the Additional Chief Secretary, the Director was assured of the following:

- 1. A proposal for mutation of 40.28 and 29.02 acres of land in favour of IIT Indore would be put up for Cabinet approval on December 18, 2012.
- 2. That the construction activity can be commenced, pending the mutation of land in favour of IIT Indore.
- 3. The matter of constantly shifting boundary by the District Administration was addressed and it was assured that the boundary as marked in the revenue map, provided by the State Government, and according to which



the complete master plan has been prepared would be the final boundary on which the boundary wall is to be constructed.

During the meeting Shri Ajit Kesari, Secretary-Revenue, Government of Madhya Pradesh, Department of Revenue had instructed Additional Collector, Indore to complete the boundary demarcation within 10 days.

# b) Stage II clearance from Ministry of Environment and Forests, Government of India:

Proposal for Stage II approval was forwarded by the Government of Madhya Pradesh, Office of Chief Conservator of Forests, vide letter no. F-5/665/10/10-11/2512 dated September 7, 2012.

Ministry of Environment and Forests, Government of India vide letter no. F. No. 8-109/2010-FC dated October 5, 2012 intimated that environment clearance of the project was to be submitted by the Government of Madhya Pradesh for according approval for the Stage – II clearance.

Application for EIA clearance was submitted by IIT Indore to Member Secretary, State level EIA authority vide letter no. IITI/Project/EC/2012/02 dated November 5, 2012. EIA presentation was made by IIT Indore to the State level EIA authority on December 17, 2012. Terms of reference, have been issued by the State level EIA authority.

#### Water Supply:

A request for grant-in-aid for water supply to IIT Indore at Simrol Campus has been rejected by the Government of Madhya Pradesh Department of Technical Education & Skill Development, Bhopal. Enclosed is D.O letter no. 1-52/2008/42-1 dated December 17, 2012 received from Mr. Shamimuddin, Additional Secretary, Government of Madhya Pradesh Department of Technical Education & Skill Development, Bhopal.

Narmada Development Authority has approved 4.5 MLD of raw water from Narmada-Kshipra-Simhastha-Link water pipeline passing from Gate – 1 & 2 of IIT Indore Simrol Campus.



# > Electricity - Substation:

The Madhya Pradesh Paschim Kshetra Vidyut Vitaran Co. Ltd. (M.P.P.K.V.V.C.L.) vide letter no. CE/IR/COM/HT-130/15459 dated November 09, 2012 has sanctioned 1,000 KVA power on 33 KV in phases as under:

500 KVA : June, 2013
 1000 KVA : May, 2015

The Madhya Pradesh Power Transmission Co. Ltd. (M.P.P.T.C.L) has intimated vide letter no. 04-02/PS/1901 dated December 29, 2012 that the work of 132 KV substation at Simrol (Memdi) shall be completed by June-July 2013.

# > Construction of Boundary Wall:

#### **NON-FOREST AREA**

The work was awarded to M/s. SKM Ramdin Ultratech Pvt. Ltd. The current progress of work is that excavation and RCC work for 6 kms of boundary wall has been completed as on January 31, 2013.

#### **FOREST AREA**

Advertisement of tender for the Construction of Boundary wall (along forest area) was floated in the national edition of leading newspapers on January 01, 2013 and the tender document was also uploaded on website, of the institute.

An estimated 3.5 km length of the boundary wall has been taken into consideration in the forest and quarry area.

The Office of Conservator of Forest at Indore vide letter no. Ma/Chi/13/690 dated January 24, 2013 has intimated that no work can be carried out on the forest land as Stage II approval has not been accorded by the Ministry of Environment & Forests. Ministry of Environment and Forests has not accorded Stage II approval, as the Government of Madhya Pradesh is yet to accord EIA clearance for the project.

As per the letter from Ministry of Environment and Forests Government of India vide letter no. F.N. /8/109/2010/ F.C. dated 3.06.2011, clause no (xxi) states as follows:

"The project area shall be demarcated on ground at the project cost, using four feet high RCC pillars, with each pillar inscribed with the serial number, DGPS coordinates, forward and backward bearings and distance from adjoining pillars etc."

#### Master Plan for IIT Indore:

The approval of Master Plan for IIT Indore was submitted to Mr. Sanjay Mishra, Joint Director, Town and Country Planning, Indore, vide letter no. IITI/RO/1-Land/10/2012/012 dated November 21, 2012.

Approval of Master Plan has been accorded on December 11, 2012.

> Meetings with the functionaries of Government of Madhya Pradesh to resolve several issues:

Meetings were held by Director, OSD and Registrar of the Institute with functionaries of the Government of Madhya Pradesh to resolve several issues.

# **8.3.2** The Board **RESOLVED** the following:

- To approach Chief Secretary, Government of Madhya Pradesh for mutation of 40.28 acres (Exchange Land) and 29.02 acres (Nizi Land) in the name of IIT Indore.
- To seek cooperation of the District and State Government administration to provide assistance, security, etc. during the completion of the boundary wall as per the original revenue map.
- 3. To construct the boundary wall in the forest area of the permanent campus at Simrol.



# ITEM NO. 8.4 To consider sanction of additional faculty posts.

- 8.4.1 Director informed that the 1:10 faculty student ratio is applicable to old IITs, this norm cannot be applied to new IITs as the faculty-student ratio will not stabilize till such time that adequate infrastructure becomes available for increasing the intake of students. Institute is receiving good applications for the faculty positions and there is a need to recruit faculty members in view of the M.Tech. and M.Sc. programmes commencing from the next academic year.
- **8.4.2** The Board **RESOLVED** to discuss the matter in the next meeting with justification for requirement of additional faculty positions in each discipline.
