9.3.1 The Board RESOLVED to confirm the minutes of the fifth meeting of the Finance Committee.

ITEM NO. 9.4.

To consider and confirm the minutes of the 5th Academic Council meeting held on April 26, 2013

- 9.4.1 Director briefed the Board about the important decisions taken in the 5th Academic Council Meeting.
- 9.4.2 The Academic Council has now been converted into the Senate. Henceforth, it will be referred to as the Senate, IIT Indore.
- 9.4.3 Director informed that the Institute is committed to the need to involve B.Tech. students in forefront and meaningful research. For this, the Academic Council has proposed a new model of six months internship in industry to the B.Tech. students and to offer Project assistantships to graduating B.Tech. students. This shall help to retain the best talent in the country to do research.
- 9.4.4 Members, BoG appreciated the new model and suggested for identifying the knowledge gap. This model shall help the students gain problem solving ability and benefit the industry. This shall also help to produce properly skilled practical hands that are comfortable to work in advanced manufacturing industries. For this, the Institute needs to build its credibility to develop research design capabilities oriented to industry needs.

- 9.4.6 Director suggested high end research and conduct of refresher courses to bridge the knowledge gap. The Institute and industry need to come together to identify what the Industry needs and accordingly the students can be geared to provide the same.
