IIT Indore is an institution of national importance. It is one of the second generation IITs, established by the Ministry of Education, Government of India, and a top ranked IIT as per TimesHigher Education. Its campus is located at Khandwa Road, Simrol, Indore, Madhya Pradesh.

IIT Indore invites applications from Indian nationals having excellent academic record and relevant work experience for the following positions on a short-term Term Contract basis:

Junior Architect:- (1 Post)

Academic Qualifications:- A B.Arch. or equivalent degree in Architecture from a reputed University/ Institute.

Experience and Skills required:- At least 2 years of working in an architectural firm. Should be able to create architectural drawings, working drawings and 3D walkthroughs based on Design Sketches given, or references provided. Must be proficient in Autocad, Sketchup, Archicad and 3D rendering software. Knowledge of software like Lumion, Escape, Twinmotion etc. for walkthroughs and 3D views will be an added advantage.

Salary: - Rs. 40,000/- consolidated per month

Age limit: - 40 Years

General Instructions:

1. All qualifications should have been acquired from Universities/Institutes/Boards/Councils etc. recognized by appropriate Statutory Authorities. The requirements of minimum qualification, experience, and/or age may be relaxed in the case of candidates with outstanding credentials and experience.

2. Candidates who have work experience in the Private Sector and producing the experience certificate should submit the experience certificate on the letter-head of the Company. The letter-head of the company should have the details of the Company Registration Number and contact details of the signatory for confirmation.
3. The candidature of the applicant shall be subject to verification of testimonials at a subsequent stage i.e., at the time of reporting for duty. In case the candidate fails to submit the required supporting documents (as mentioned by them in their CV), his / her candidature may not be considered for interview.

5. The appointment will be initially for 06 months on Short Term Contract (STC). That will be renewed for a further period based on the periodic performance review of the candidate and the needs of the Institute. Selected candidates will be entitled for OPD facilities at Institute Health Centre. He / She will also be entitled for Leave as per Institute rules.
