Advertisement for a Field Assistant/Project Associate/ Research Associate Position

Applications are invited from motivated and eligible candidates for a **Field Assistant/Project Associate/ Research Associate** position in the research project *Technological Innovation and Intellectual Property*. The principal objective of the proposed study is technological innovation and IPRs ecosystem. It is essential to evaluate different STI policy interventions designed to incentivize sustainable environmental practices related to water, waste, agriculture and climate change, innovation activities for academia, companies, and small and medium enterprises by the government and IPR Ecosystem.

For Field Assistant

Eligibility: Graduate degree in any discipline. Prior Experience is preferred.

Stipend: Rs. 18,000+HRA as per DST rule

For Project Associate

Eligibility: Master's degree or Bachelor's degree in Eng in Water/Environment/Economic/ Public Policy/ Development /related areas.

Stipend:

Rs. 31,000 + HRA for candidates who have qualified UGC-NET including lecturership (Assistant Professorship) or GATE HSS or similar examinations conducted by Central Government Departments and their Agencies and Institutions. Candidates who have not qualified for the above conditions are entitled to a fellowship of Rs. 25,000 + HRA.

For RA Position

Eligibility: Ph.D. degree or having 3 years of research, teaching, and design and policy experience after ME/M.Tech. with at least one research paper in Science Citation Indexed (SCI) journal in relevant field

Stipend:

Postdoctoral Fellow will be paid consolidated salary based on the following salary structure of the DST for Research Associate.

Research Associate-II Rs. 49,000/-
Research Associate-III Rs. 54,000/-

The category will be decided/recommended by the selection committee based on the qualification /Experience /Performance in the interview of the candidate.
