



Engagement of Visiting Consultant Doctors

IIT Indore invites applications from Indian nationals having excellent academic record and relevant work experience for the following position on contract basis:

(A) Ophthalmologist: - 01 Post

Qualification:

- MBBS degree from a University recognized by IMC including completion of Compulsory Rotatory Residential Internship (CRRI).
- MS/ DNB Ophthalmologist from a university recognized by IMC.
- Registration for medical practice in Madhya Pradesh. Applicable who do not have registration in Madhya Pradesh shall submit within a stipulated time.

Experience:

- Minimum experience of 10 years.
- Candidate with less years of experience from a reputed Institute may apply.
- Preference will be given to persons having experience from a reputed Institute may apply.

No. of Visit:- 3 to 4 visit per month as required.

Upper Age Limit: 70 Years

Honorarium: The Honorarium payable to the Visiting Consultant would be fixed of Rs. 7000/- per visit (including Transportation Charges)

(B) Dermatologist:- 01 Post

Qualification:

- MBBS degree from a University recognized by IMC including completion of Compulsory Rotatory Residential Internship (CRRI).
- MS/ MD/DVD or DNB Dermatology from a university recognized by IMC.
- Registration for medical practice in Madhya Pradesh. Applicable who do not have registration in Madhya Pradesh shall submit within a stipulated time.

Experience:

- Minimum experience of 10 years.
- Candidate with less years of experience from a reputed Institute may apply.
- Preference will be given to persons having experience from a reputed Institute may apply.

No. of Visit:- 3 to 4 visit per month as required.

Upper Age Limit: 70 Years

Honorarium: The Honorarium payable to the Visiting Consultant would be fixed of Rs. 7000/- per visit (including Transportation Charges)

Terms and Conditions:

1. The engagement of visiting consultants will be purely temporary and will not confer any right to them to claim the status of a regular employee of the institute.
2. The Visiting Consultant will not be entitled for any other Allowance or Benefits other than those indicated above.
3. The Visiting Consultants will abide by the Institution Rules and Regulations governing their engagement.
4. The Visiting Consultants will safeguard the security and confidentiality of all official matters and secrecy of information coming to their knowledge.
5. The Honorarium is fixed and there is no scope of negotiation for honorarium or any other allowance.

Termination of Engagement:

The Engagement of the Visiting Consultant will stand automatically terminated on completion of prescribed tenure as specified in the Offer of Engagement. The Engagement can be terminated even earlier, with one month Notice in writing either side.

Selection Criteria: (Certificate Verification and Interview)

General Instructions:

1. Experience will be reckoned on the last date of submission of application.
2. Candidature of the applicant shall be subject to verification of testimonials at a subsequent stage i.e., at the time of interview. In case the candidate fails to submit the required supporting documents (as mentioned by them in their application /CV), his / her candidature shall not be considered for the interview.
3. Applications received through incomplete / not on prescribed format without relevant documents will not be considered.
4. Candidates will not be paid any amount towards their traveling /other expenses to appear in practical test/interactive session.
5. Short-listed candidates for interview and finally selected candidates only will be informed individually via e-mail correspondence on their registered e-mail.
6. Only shortlisted candidates will be called for the interview.
7. The appointment will be initially for three months and later for a year. That will be renewed for a further period based on the performance of the candidate and the needs of the Institute..
8. No interim correspondence will be entertained. Information about the shortlisted candidates and dates of the interview will be informed through email.
9. Decision of IIT Indore will be firm and final.
10. Candidates, who are fulfilling the above eligibility criteria, and are willing to apply for the post are requested to apply through email at "careers@iiti.ac.in" on or before August 11, 2024 upto 5:30 pm with the following details:
 - (a) Updated CV clearly mentioning the age, qualification, and experience details with a self-attested set of photocopies.
 - (b) List of 3 references with complete contact details.
