The principal objective of the proposed study is technological innovation and IPRs ecosystem. It is essential to evaluate different STI policy interventions designed to incentivize sustainable environmental practices related to water, waste, agriculture and climate change, innovation activities for academia, companies, and small and medium enterprises by the government and IPR Ecosystem.

For Field Assistant

Eligibility: Ph.D. degree or having 3 years of research, teaching, and design and policy experience after ME/M.Tech. with at least one research paper in Science Citation Indexed (SCI) journal in relevant field

Postdoctoral Fellow will be paid consolidated salary based on the following salary structure of the DST for Research Associate.

The category will be decided/recommended by the selection committee based on the qualification /Experience /Performance in the interview of the candidate.
