Key responsibilities include assessing carbon dynamics in soil, vegetation, and water; analyzing seasonal variability and spatial distribution of carbon; identifying pollution sources; designing strategic recommendations for conservation and enhancement of carbon sequestration contributing to the ecological health of wetlands.
