- (a) Essential Qualification: Masters' Degree with at least 55% marks or its equivalent with an excellent academic record.
- **(b) Essential Experience**: 3 years administrative experience in a post carrying Pay Level 8 (Grade Pay of Rs. 4800/- as per 6th CPC) or equivalent OR 5 years' experience in pay level 7 (Grade Pay of Rs. 4,600/- as per 6th CPC) or equivalent OR 8 years' experience in pay level 6 (Grade Pay of Rs. 4,200/- as per 6th CPC) or equivalent. Desirable: (i) Professional qualification in area of Management/ Finance & Accounts (ii) Experience in handling Administrative, Legal, Finance, Academic, Materials Management, Patents, Research Project Management, Student activities, international relations, Alumni relations etc. Pay: Pay Level: 10 (Rs. 56,100 1,77,500/-) (Pay Scale: Rs.15,600-39,100/- with Grade Pay of Rs. 5400/- as per 6th CPC).
